I. AWARDS DEFINITIONS AND POLICY

- The Technology Award program is intended to acknowledge and celebrate technologies demonstrating innovation, and having impact in the entertainment media industry, including theatrical, video, virtual reality and augmented reality.
- Technologies to be considered for an Award include image generation, capture, production, post-production, conversion, software, cameras, projectors, display devices, head-mounted displays, capture systems and related new innovations.
- Examples of advanced imaging include, but are not limited to: High Dynamic Range (HDR), High Frame Rate (HFR), Wide color Gamut (WCG), new display technology (e.g. 8K OLED), stereoscopic 3D capture, conversion or display, holographic / lightfield, virtual reality, augmented reality and volumetric image capture.
- The recipient(s) for this award will be the Organization or Individual responsible for the commercial launch of the technology.
- Awards shall be conferred at the Advanced Imaging Society Awards ceremony on January 16th, 2018.
- Each recipient shall receive one Advanced Imaging Society Technology LumiereTM statuette.
- In order to promote the natural course of uninhibited industry achievement, recognition will not fall into specific categories.
- Product has to have been implemented between November 1, 2016 and October 31, 2017.

II. ELIGIBILITY

- A Press Release will be issued by the Advanced Imaging Society in order to solicit nominations.
- Eligibility is contingent upon approval by the Advanced Imaging Society Technology Awards Committee will be issued by the Advanced Imaging Society in order to solicit nominations.
- In the event of any dispute concerning credits, the Advanced Imaging Society reserves the right to declare any achievement ineligible or alternatively, to reject all claims to credit, list credits as being in controversy and withhold any award until the dispute is resolved.

III. DEADLINES

- All Advanced Imaging Society Technology Award Nominations must be submitted by either:

- Deadline for all Nominations is 6PM PST, November 30th, 2017.

- The Advanced Imaging Society Technology Awards Committee will follow up with nominations at their sole discretion.
- Any person(s) nominating for the Advanced Imaging Society Technology Awards agrees to comply with the reasonable requests of the Awards Committee for additional information within a reasonable amount of time as deemed appropriate by the Awards Committee.
 Nominations may be disqualified if reasonable requests for additional information are not met.
